AIP AMDT/CHARTS AIRAC PRODUCTION SCHEDULE 2024

Introduction

AIRAC (Aeronautical Information Regulation And Control) is a system aimed at advance notification, based on common effective dates, of circumstances that necessitate significant changes in operating practices.

The dates are in line with the ICAO objective (Annex 15) to provide at least 28 days advance notification of significant changes to operational services, facilities and procedures. Cut-off dates for the text amendments allow the minimum time for processing and distribution to provide 28 days advance notification to clients prior to effective dates.

Definitions

Cut Off Date – The date after which AIS will not accept any further changes to data or information.

Effective date – The date on which the changes become operationally effective.

AIP Review Group Date – The date on which the AIP Review Group will meet to discuss and approve the proposed changes to the AIP Fiji and Aeronautical Charts.

Procedures

Proposed information or data not with AIS by the appropriate cut off dates will be held over until the next schedule dates.

Whenever major changes are planned and where additional notice is desirable and practicable, a publication date of at least 56 days in advance of the effective date should be used.

It is the responsibility of the data originator to verify and validate all the data and information prior to sending it to AIS for publication in the AIP Fiji.

Amendment Interval

Regular amendments to the AIP Fiji Islands are issued every 4^{th} , 8^{th} and 12^{th} AIRAC cycle per year.
