INTEGRATED AERONAUTICAL INFORMATION PACKAGE - FIJI

1. Introduction

The Fiji Integrated Aeronautical Information Package, consisting of AIP, including amendment service; supplements to the AIP; NOTAM; PIB; and AIC is published under the authority of the Civil Aviation Authority of the Fiji. All elements of this package have been delegated to Airports Fiji Limited, except for the Aeronautical Information Circular (AIC).

AICs are published by the Civil Aviation Authority of the Fiji (CAAF). Enquiries concerning the contents of the circulars should be directed to CAAF at the above address.

2. Contents

The AIP Fiji is a single document divided into: General (GEN), En-Route (ENR) and Aerodrome (AD). It also includes maps and charts. The section contents are as follows:

- GEN Section – consists of five sections containing information of an administrative and explanatory nature,
- ENR Section – consists of seven sections containing information on airspace and its usage,
- AD Section – consists of four sections containing information on aerodromes and their use.
 - Instrument Approach Charts
 - Aerodrome Charts
 - Aerodrome Ground Movement Charts
 - Standard Departure Chart - Instrument (SID)
- Maps/Charts –
 - Nadi FIR Oceanic EnRoute Chart
 - Area Chart - VORRoutes
 - Area Chart- NDB Routes Chart
 - Area Chart - RNAV Routes Chart

3. Amendment procedures

The Aeronautical Information Services Section is responsible for producing and distributing the AIP Fiji, AIP Supplement, Aeronautical charts and associated amendments in accordance with the AIRAC system of notification. The Fiji AIP is amended on every 4th, 8th and 12th AIRAC cycle each year.

AIP Supplements contain information of a temporary nature. They may also temporarily contain information of a permanent nature intended to be transferred to the AIP at the next AIP amendment opportunity.
